
## **Multicolor Light Bar**

- 8 static and 4 dynamic color settings with 4 sound reactive modes

- Multi-position base for horizontal and vertical mounting orientations
- Includes remote control with up to 15 ft range
- Conveniently plugs into any 5V USB power source (not included)

### **SETUP**

 Determine where and in what orientation you would like to use your Multicolor Light Bar



- 2. Slide base into either slot, one in the middle of the light bar for horizontal viewing. The other at the end of the light bar for vertical viewing.
- 3. Plug USB end of cord into a 5V USB home charger (not included).
- 4. Use the included remote control to power on/off, change colors and set color modes.

#### REMOTE CONTROL

# Operation:

- 1. Turn on the Light Bar by pushing the ON button on the remote control.
- Select the desired color of the desired effect by pushing the corresponding button on the remote control.
- Set the desired brightness using the buttons to increase/decrease the intensity of color.
- 4. Push the OFF button to turn off the Light Bar.



1	Dimmer Buttons	Adjust Brightness/Intensity
2	On Button	Turn product On
3	Off Button	Turn product Off
4	Multi Color Selector	Change the color to match your mood
5	Music Reactive Mode	Changes color with the beat of music
6	Color Modes	Fading/Jumping between colors

### CHANGING REMOTE CONTROL BATTERY

The battery for the remote control has already been installed. Remove the battery pull tab to operate.

- 1. The battery compartment is located on the narrow side of the remote control.
- Remove the empty battery and insert a 3V battery, type CR2025. The positive terminal must point upwards.
- 3. Place the battery compartment back in the remote control so it locks in place.
